JESSE ABNER SAGE, son of Rev. T. J. and Mary Benton Sage, was born near Lake Providence, La., May 21, 1862, and died at his home in Magnolia, Ark., on January 24, 1938. His funeral services were conducted at the church by Neill Hart, Leland Clegg, E. C. Rule, Frank Scott, J. M. Workman, Clem Baker, and J. B. Luck (of the Baptist Church). He was buried in the cemetery at Magnolia. Early in life he moved with his parents to Emmet, Ark. He was licensed

to preach by the Emmet Circuit on July 11, 1885, and was admitted on trial into the Little Rock Conference in the fall of that year. His appointments were: Fulton Circuit, two years; Mount Pleasant Circuit, three years; Stephens and Waldo, four years; Hot Springs District, four years; Magnolia Station, two years; El Dorado, four years; Hamburg, two years; Fordyce, two years; Benton, one year; Crossett, three years; Pine Bluff District, four years; Camden District, four years; Prescott District, four years; Fairview, Texarkana, two years; Lewisville and Bradley, two years; Blevins, two years. He was superannuated in November of 1930. On March 24, 1887, he was married to Mrs. Mary C. Whiteside (widow of Rev. W. B. Whiteside), who survives him. Mrs. Whiteside had three daughters, and three daughters and four sons were born to the Sage union. One daughter, Bennie, died from an accident at about three years of age. The Whiteside children surviving are: Mrs. T. P. Gantt, Miss Florence Whiteside, and Mrs. Nick Wells. The Sage children are: Mrs. W. J. Moore, Mrs. W. R. Mahaffey, J. Abner, Jr., Leland Raymond, and John Sage.—*C. J. Greene.*

JOHN WILLIAM HARRELL was born in Hinds County, Miss., March 12, 1859, the oldest of ten children born to George W. and Effie Ballard Harrell. In 1883 he moved to Arkansas with his family and located on a farm near Sheridan in Grant County. He was married on April 15, 1891, to Miss Gussie Williams. To them six sons and one daughter were born, all of whom (with the exception of the eldest child, Joseph Freeman, who died at the age of five) survive him. They are: Van W., Olin, Don W., and Bert Harrell, Mrs. George Wilbur, and John Harrell. He was licensed to preach by Dr. J. H. Riggin. During the next four years he served as a local preacher. In 1894 he was ordained a local deacon by Bishop Hargrove at the North Texas Conference at Bonham. That same year he returned to Arkansas and in the spring of the following year he was appointed to Sherrill Circuit. In 1896 at the Little Rock Conference in Camden, Bishop Key presiding, he was admitted on trial. Among other appointments he served nine years on the Monticello, Pine Bluff, and Camden Districts. At the Conference of 1931 he was superannuated and located in Camden. He died on June 5,

1938. The funeral services were conducted from the church in Camden by B. F. Scott, W. C. Watson, and the writer. Burial was in Camden cemetery, near the grave of his brother, F. F. Harrell.—*C. M. Reves.*

ROBERT A. MCCLINTOCK, son of Dr. A. H. and Cynthia Evans McClintock, was born June 16, 1854, in western Tennessee. At eighteen years he was given local preacher's license. On January 2, 1876, he was married to Miss Rose Anabel Brown. Two years later they moved to Ripley County, Mo., where he continued teaching and ministering as a local preacher for two years. He was admitted on trial into the St. Louis Conference in September of 1880. After fourteen years he transferred from DeSoto Station, St. Louis Conference, to Portland-Parkdale, Little Rock Conference. His wife died at Wilmar on April 30, 1915. Brother McClintock was granted the superannuate relation in November of 1925. He was married to Mrs. Willie Cotner on March 21, 1918. After superannuation he came to Wilmar, where he lived until his death on June 13, 1938. Two of the six children, born to his first marriage, survive him: Mrs. A. J. Snodgrass and Mrs. Eva Nunn Daniels. He is also survived by two grandchildren, one great-grandchild, and his wife.—*J. R. Sewell.*

S. C. DEAN was born in Lawrence County, S. C., on September 19, 1854, and died at his home in Hamburg, Ark., on August 17, 1938. He came to Arkansas with his parents in 1857, settling in Pike County. In 1859 he lived on a farm where the town of Delight now is located. He entered the University of Arkansas in 1877 and spent four years there. He taught school several years and was principal of the schools at Murfreesboro from 1883 to 1884. He was married to Miss Nora Scott, daughter of Rev. W. J. Scott, by Rev. E. Garrett at Murfreesboro on March 2, 1887. Brother Dean was licensed to preach by the Little Rock Conference on October 31, 1891, and served the following charges: 1892, Attensas Circuit; 1893, Maumelle Circuit; 1894, Lono Circuit; 1895-98, Princeton; 1899-1900, Okolona Circuit; 1901-03, Dalark Circuit; 1904-05, Lockesburg Circuit; 1906-09, Fairview, Texarkana; 1910-12, Benton; 1913-14, Third Street, Hot Springs; 1915-18, Hamburg; 1919, Der-
