Mrs. Celia F. Dillow (1873-1949)

Mrs. Celia Frances Dillow, wife of the late Rev. S. B. Dillow, was born at Winterset, Iowa, September 19, 1873, and departed this life January 9, 1949, at Lincoln, Nebraska, at the age of 75 years, 3 months and 21 days.

She was united in marriage to John F. Daniels, on July 1, 1890. Their home was established near Doniphan, Nebraska, and two children were born, one dying in childhood. She was united in marriage to the Rev. S. B. Dillow of the Nebraska Conference on June 11, 1919, and was a devoted ministers' wife and companion for eleven years, when he died January 6, 1930. She served with him at Hastings Grace, Lincoln East, the Lincoln and Kearney Districts and Blue Springs, after which they retired in Lincoln, Nebraska.

A fine service was rendered through her sincere devotion and support of the regular church worship services and the prayer meetings of the Lincoln Calvary Church; the missionary enterprise and the Riverside Park Assembly.

One daughter, two step-daughters, three step-sons and four sisters and a host of friends survive.

The funeral service was conducted January 12, 1949 at the Calvary Evangelical United Brethren Church by the pastor F. F. Gross, assisted by the Conference Superintendent, Wm. G. Rembolt. Interment took place in the Wyuka cemetery at Lincoln, Nebraska.

Mrs. Anna Holdeman (1866-1949)

Mrs. Anna Lavina Holdeman nee Kletzing, was born on July 26, 1866 in Limbrick, Montgomery County, Pennsylvania and passed into eternity at the age of 82, at the home of her daughter in Whitewater, California. She moved with her parents to Belle Plaine, Iowa, at the age of four and to Blue Springs, Nebraska, in 1882.

Marriage with the Rev. Josiah Holdeman took place March 5, 1885. Four children were born to this union. They served more than 37 years in the Christian ministry on many charges in the Nebraska Conference (Ev) and retired to California in 1925, where he died in 1934. Two children preceded her in death.

Mrs. Holdeman possessed a fine missionary fervor and served the Cause as a Branch president, assisting in organizing several societies and being a member on the Executive Board of the Woman's Missionary Society for a number of years, as well as being the Nebraska representative at the General Board of Missions on three occasions. Her service extended also into her home life where she rendered unselfish devotion to an invalid daughter for thirty years. She is survived by two daughters and a host of friends.

The final tribute service was held March 24, 1949 at Anaheim, California, and interment took place beside her husband and daughter in Loma Vista Memorial Park in Fullerton, California.
