#### Peoria, Grace

(a) In regard to the request from Peoria Grace Mission for financial help in meeting their obligations, we recommend that a loan of \$1000.00 from the Church Extension Board be made, for five years. The Conference Board of Trustees is authorized to sign the necessary papers.

(b) We recommend that the action of the Conference Board of Trage tees in 1925, deeding the vacant lots in South Peoria to the trustees of Grace Church, Peoria, be ratified, to clear the title.

#### Richland

Inasmuch as the Richland Society comes to Conference requesting help to the extent of \$1500.00 toward making necessary repairs and improvement on their church building, it is hereby

Resolved, That the sum of \$1500.00 be loaned to the Richland Church trustees for a period of two years at two per cent per annum, from the treasury of the Conference Board of Trustees.

#### Robertsdale

In response to a request of the Robertsdale Mission for aid, We recommend that the sum of \$1000.00 be loaned to the trustees of the Robertsdale Church from the Church Extension Board. The Conference Trustees are hereby authorized to sign the necessary papers.

#### Wooddale

Whereas, new angles have arisen in connection with the church property at Wooddale, we direct that the Conference Board of Trustees be, and they are hereby authorized with power to act in safeguarding the interests of our Conference in the premises.

Nicolaus Wunderlich, a veteran of the cross, and a product of this conference was recommended for the holy ministry by the Hollands Grove Church and licensed to preach the Gospel by this conference at its annual session in 1880. He then entered the Michigan Conference where he served for some years, and, coming back to his mother conference, he served many charges very acceptably. Brother Wunderlich was a good preacher and pastor, and a dear Brother Beloved. He passed to his reward on June 7, 1928, at a good old age.

Rev. J. H. Keagle, was born in May 1857, at Durand, Illinois. Shortly after his conversion as a young man, he felt definitely called to the holy ministry and applied to this conference for license to preach the Gospel at its session in Peoria, Illinois, in 1886. He at once entered his chosen work, and remained in the active service until he was necessitated to fetire on account of failing health in the spring of 1924. After several years of patient suffering, he fell asleep in Jesus on November 11-1928.
