CHARLES G. GOMON

He received his grade school education in a rural school pear Lake Delton, Wisconsin, and graduated from the Baraboo, Wisconsin, High School. He attended Northwestern University for one year before enrolling at Nebraska Wesleyan University where he received his degree. In later years he was awarded an honorary Doctor of Divinity by Nebraska Wesleyan University.

Dr. Gomon first served in the ministry of The Methodist Church in the State of Wisconsin. He moved to the Nebraska Conference in 1907 and served as minister of the Methodist churches of Giltner Epworth Church in Lincoln, Ravenna, Cozad, Broken Bow, Aurora and Albion. He then served as District Superintendent of the Norfold District for five years, before accepting the pastorate of St. Paul Church in Omaha, where he served two years. In 1934 he became Executive Secretary of the Conference Claimants Society, with offices in Omaha; a position he was to fill for fifteen years before retring in 1949.

Dr. Gomon was married on November 28, 1901 to Mary Estella Hepburn at Prairie Farm, Wisconsin. To this union two sons were born, Horace and Neal.

He was a member of the Masonic Lodge, the Knights Templat, and the Peru Kiwanis Club.

Shortly after his wife's death in 1955, he moved to Peru where he has since lived.

He is survived by his two sons, Horace W. Gomon of Lincoln and Dr. Neal S. Gomon of Peru, Nebraska; five grandchildren; three grandchildren; one sister, and three brothers.
