

ANDREW LINCOLN SIMMONS

Andrew L., son of Amos and Phebe Simmons, loyal adherents of the cause of the Union during the Civil War, was born on a farm near Harrisville, West Virginia, on June 11, 1866. Death came for him, after a long illness, on January 13, 1944, at his home in Algonac, Michigan, where he had lived since his Retirement.

He began his career as a farmer but feeling called to the ministry he made preparation for his life work at West Virginia Wesleyan College, at Clarksburg. He did supply work for several years, first in his home community of Harrisville, and then for seven years at Gainsville, Missouri, in the foothills of the Ozarks. Here he served a circuit of seven churches with the parsonage forty miles from a railroad.

He was Received on Trial in the St. Louis Conference (Spring) in 1907. He transferred to the Illinois Conference in 1908, serving faithfully in various appointments until 1931 when he was granted the Retired Relation because of impaired health. He was an humble man who did not aspire to position or prominence but the small churches which he served had as their minister one of the best men of our Conference in true Christian life and character.

He was united in marriage with Miss Elspeth Lecten of Cairo, West Virginia, on March 28, 1899. To them four children were born: Walter, who died in 1931; Mrs. Cecil Bennett and Marvin, both of Dearborn, Michigan; and James of Algonac, Michigan.

Mrs. Simmons survived her husband by but three days and a double funeral service was held for them by the pastor of Trinity Methodist Church, Algonac. Interment was in Fairlawn Cemetery, Algonac.

GEORGE PARKER SNEDAKER

George Parker Snedaker, born April 3, 1862 at Pleasant Hill, near Lexington, Illinois in a parsonage home, his father being a Methodist minister whose services to the Conference extended back to 1857. He passed away at his home in Piper City on June 5, 1944 and was gratefully remembered in a memorial service at the Piper City Methodist Church on June 10, 1944.

Mr. Snedaker graduated from Hedding College in 1887 and went out to do Home Missionary work in the western states. He was ordained Deacon at Ord, Nebraska, in 1889 and two years later was ordained an Elder at Rapid City, South Dakota. He served in Western Nebraska and Wyoming until 1907, when he returned to Illinois taking a charge on the western side of the Conference. He served the latter half of his ministry in the eastern half of the Conference, retiring in 1935, but continued to serve until 1941, when he moved to Piper City.

He married Clara Shoop of Abingdon, October 3, 1889. Seven children were born to them, three of whom preceded him in death. Surviving are Mrs. Snedaker, Mrs. John Wilson of Piper City, Mrs. E. M. Jeffords of Wilmette, Miss Sylvia Snedaker of Chicago, and Clement Snedaker of Evanston. A sister, Mrs. J. M. Shipplett of Abingdon, and five grandchildren, also survive.

Mr. Snedaker's ministry was characterized by friendliness, interest in youth, and genuine helpfulness. He had the honor of dedicating a debt-free Church at Saunemin, and was made Pastor Emeritus of the Piper City Church in 1942, where he gave his fine influence until the end.

District Superintendent Arthur P. Jordan gave the message at the funeral service, at which also L. P. Bear, John T. Killip and W. E. Shaw gave brief tributes. A large group of brother ministers were present and sang "In the Sweet Bye-and-Bye". Burial was in the Piper City cemetery.
