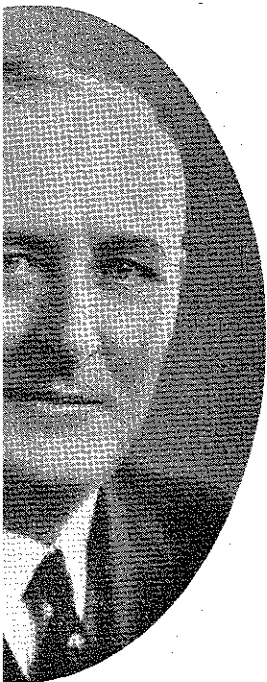

VII MEMOIRS

REV. JULIUS STEDMAN SMITH

Julius Stedman Smith, an early Methodist itinerant and pioneer preacher passed to his reward at National City, California, Thursday, October 6th, 1932, and was buried in the Mt. Hope Cemetery, San Diego, Saturday, October 8th. Rev. Horace B. Sellers, pastor of the National City Methodist Episcopal Church, had charge of the service, assisted by Rev. H. H. Weyant, a retired member of the Southern California Conference and the Datus E. Coon Grand Army Post, No. 172, of which Brother Smith had been a former commander and member. Brother Smith was born at Athens, Ohio, March 11, 1845. He was converted during a revival at the age of 14, and immediately joined the Methodist Church on probation after being baptized. He entered the Ohio University and graduated in 1866. He was first licensed to preach in 1867, and was admitted to the Nebraska Conference in 1872. His first appointment included all of the west half of the State of Nebraska, a territory which later became the seat of two Conferences and a part of a third. The territory then was sparsely settled. After the Indians stole the one horse he had, he frequently walked twenty miles a day, as well as preaching three times. After a break in health, Mr. Smith preached for two years in the United Brethren Church, then returning to the Methodist Church, united with the Kansas Conference in 1883 and served as chaplain of the Kansas State Penitentiary for eighteen months. In 1885 on account of his wife's health he was sent to the New Mexico Mission, where he was instrumental in the starting of Rio Grande College, now the Harwood School. In 1887 he returned to the Kansas Conference and in 1892 he was transferred to the Oregon Conference, where he served at Grants Pass, Ashland and Independence; to the California Conference, where he served at Byron, Turlock, Antioch and Sonora; and to the Columbia River Conference, where he served at Ellensburg, Palouse, Garfield, and Grangeville, Idaho, from which place he retired in 1904. After retirement he lived for a time in Ashland, Oregon, coming to San Diego in 1917 and to National City in the latter part of that same year. He is survived by his daughter, Lucy L. Smith, who tenderly cared for her father during his years of retirement and failing health.

REV. JULIUS C. HARVEY

Death again invaded the ranks of the retired ministry of the Pacific Northwest Conference when Julius C. Harvey passed to the Great Beyond on December 7, 1932. Death occurred at Puyallup, Washington. Brother Harvey was born June 15, 1862, was married September 2, 1884, and entered the ministry in the Northwest Iowa Conference in 1893 on trial, and was admitted to full connection in 1895, graduating from the course of study in 1897. Mr. Harvey had a long and honorable ministry. From 1894 to 1902 he served in the Northwest Iowa Conference. He then transferred to the South Dakota Conference, serving just one pastorate. He then transferred to the Columbia River Conference, where he served until the consolidation of that conference with the Puget Sound Conference, forming the Pacific
