

release came peacefully, and quietly he entered into Eternal Rest.

Brother Webster served many charges, among them Sparta, Herrin, Effingham, Litchfield, Gillespie, Centralia Second, Hoyleton and Central City Church, West Frankfort Central, and Carlyle. After retirement he served 11½ years as Supply Pastor in Benld. In all these there was manifested a wonderful leadership.

He was Secretary of the Committee on Conference Relations for a number of years and was always ready to report accurately for the Committee and aided much in the advancement of the work of the Conference.

He died June 4, 1958 in Lawrenceville, age 86 years, 10 months and 14 days. The funeral services were held in Central City Church where he attended the last three years of his life.

Dr. Paul B. Brown, Superintendent of the Lawrenceville Home presiding, Dr. M. C. Foltz offering the prayer, Rev. R. D. Emmerson the pastor read the Scripture and Dr. C. C. Hall preached the sermon.

A number of other ministers were present and a large audience gathered to pay tribute to the life and worth of this soldier of the cross.

Interment was in Oakwood Cemetery, June 7, 1958.

Washington S. Wilcox, the son of James W. and Mary E. Wilcox was born in Washington, Indiana, June 29, 1870.

Rev. Wilcox joined the Southern Illinois Conference in the year of 1908. He served the following charges: Tamaroa, Reevesville, Xenia, Sumner and Wheeler. In 1949, he retired and moved to New Albany, Indiana. He moved to the Methodist Home in Lawrenceville, Illinois in 1956 where he lived until deathcame on July 6, 1958.

Rev. and Mrs. Wilcox were united in marriage in 1893 at Fries, Virginia. To this union were born 11 children. Also, those who survive are, Grace Basden, Viola Stroube, Blanche Logan, Paul and Clyde S. Wilcox.

Rev. Wilcox's funeral was held in Ashley, Illinois with Dr. C. C. Hall and Dr. Paul B. Brown officiating. Interment was in the Ashley Cemetery.

Rev. Joe T. Smith was born near Galatia, Illinois and died at Eldorado, Illinois, January 8, 1958 at the age of 80 years.

He was converted and felt the call to the ministry. He began his ministry in the Methodist Episcopal Church, South and served there until the union of the three Methodist Churches in 1939. Then he finished his ministry in the Methodist Church of the Southern Illinois Conference, retiring in 1945. He served the following charges: Stonefort, Tioga, Clarksdale, Buckhorn, Girard, Kinmundy, Casey, Moccasin, Cambria, Grand Tower, Pulaski, Dix, Rushville, Shobonier, Shattuc-Ruey, Mt. Vernon Circuit, Worden, Tate's Chapel, Creal Springs, and Upper Salem.

Rev. Smith joined the Conference by way of the Course of Study. He was a good preacher and a fine pastor, loving his people and winning them to Christ and the church. He spent 47 years in the active ministry.

He leaves to mourn his home-going his second wife, Lillie; two sons, Clinton Smith of Gary, Indiana and Leland Smith of Murphysboro, Illinois; two step-children, Mrs. Thelma Starrick of St. Louis, Missouri, and Mrs. Ruby Tate of Pontiac, Michigan.

Funeral services were held in the Methodist Church in Galatia, Illinois with Rev. John W. Ditterline in charge assisted by the pastor, Rev. H. L. Peyton. Burial was in Tate's Chapel cemetery.
