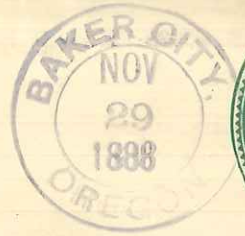
Yours of the 18th received. I have been ashore but a few days in the last month. Was in Portland when I saw a notice of the fire in the "Oregonian".

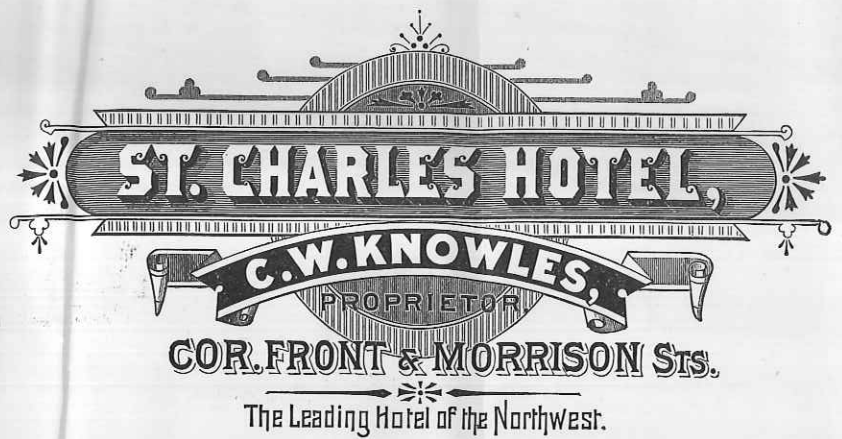
When I saw you last I had intended to have been in Salem before this time, but the party from the east who intended to operate in the real estate business there has not yet come out. Am looking for him soon.

Paris France - Aug 23rd 1889

Brother Gerrish,

I have been in Europe about two months, and have spent most of the time in London and Paris - of course I have spent but few idle hours. Time is too precious, to waste - there is so much of interest to see and learn, that we feel the value of minutes of Time. In London, the most interesting place is Westminster Abbey, one of the most interesting places in the world. Here sleep the Kings and Queens, and the good and great, who have figured in English history for more than a thousand years. Within these venerable walls, are contained the remains and Statues of thousands. Of course, we visited the Museums, Royal gardens and the Tower of London, one of the saddest places of Europe. The former residences of our Kings, in the barbarous ages, these are now a matter of history. Paris is magnificent, there is but one Paris -

Everything about it is on a grand scale - beautiful
and artistic - only the French could of built
it. There is nothing like it in the world. I have spent
many pleasant days visiting the many pleasant places
of interest. including the Exposition - stood on the top of
the Eiffel Tower, 1000 feet in the air. the highest monument
in the world is Washingtons - 525 feet. Eiffel 1000. I have
had a pleasant time here - had an invitation to visit
the international congress for the promotion
of Science. Spent several mornings with them
met many of the great Scientists of the world.
I leave here in a few days for the Rhine Country.
Will visit Holland. the Rhine Cities. Sail up the
Rhine. visit the old Home near Baden-Baden.
There is an old convent there. 600 hundred years old
named "Lichtenhaler." I learn that some
of my grandfathers relatives were monks
in this old convent before the reformation,
many hundred years ago. Will pass through
Switzerland, pass under the Alps through
the tunnel. 14 miles long, into Italia. Visit
Venice - Florence - and Rome - and its many
objects of interest. the Pope included if possible
and will return to Paris in October to Southern Switzer-
land, wish to compare the Alps with our Oregon
mountains, Bro L - I wish it were
possible for you to spend a few months
in this interesting country. I know you would

enjoy the experience - very much.
I will spend a few months in the
most interesting portions of Europe, and
shall try and see as much of it as possible
and learn from personal observations
as ^{much} as I can within the limited time allowed
me. I will not return until late in
October. Must spend a few weeks in England
making purchases for my cabinet. I will
have one of the finest private collections
in America. I am greatly to hope that
Josie will take an interest in some department
of Natural history. I am proud to believe
that child will make a name for herself.

in the world's history, of causes can all
aspire that the world may be better and
wiser on account of our lives, I honestly
think that girls of carefully educated and
careful parents will be a worthy monument
to your memory. May Heaven so order
it; I trust the summer may bring you
health and comfort, I have not heard
from the girls since I came here - hope they
are well - shall be pleased to hear from you
